We funded a suicide prevention/awareness program through The Forsyth County Schools specifically for West Forsyth High School.

The Forsyth County Board of Education worked with us to implement the program. The school district purchased the program for all 5 high schools; therefore, the check was made payable to Forsyth County Schools. We funded the program for West Forsyth High School.
